You may not know some of the terms we use in this document. Here are some meanings that may help you to understand the information we are providing.

Terminology	Description		
Benefit year	This is a calendar year, from 1 January to 31 December. This medicine list (formulary) is only valid for the specific benefit year.		
Fund Rate	This is what we will pay for healthcare services you have received from hospitals, pharmacies, and other healthcare professionals.		
NAPPI Code	This is a unique identifier for a given medicine, surgical or consumable product.
