## HOW TO JOIN THE DIABETES CARDIOMETABOLIC CARE PROGRAMME

If you are registered on the Chronic Illness Benefit for diabetes, you automatically have access to the Diabetes Cardiometabolic Care Programme through your chosen Premier Plus GP.

If you are not yet registered, ask your doctor to help you get started.

## YOUR DOCTOR WILL WORK WITH YOU TO MANAGE YOUR CONDITION

The Diabetes Cardiometabolic Care Programme is based on international and locally accepted clinical and lifestyle guidelines. Through the programme, you and your doctor (who must be on our network) can:

- Agree on key goals
- Track your progress on a personalised dashboard on HealthID (a system for doctors)
- Generate your Diabetes Management Score to help identify which areas to focus on to stabilise your condition and improve your overall health.

**If you visit a doctor who is not part of the Premier Plus Network for a chronic condition, you may have to pay part of the cost.**

To avoid any co-payments, please choose a network doctor and make sure we always know who your network doctor is. Let us know if anything changes so we can update our records.

### Other benefits and tools

- **Extra test strips:** The Fund will pay for extra blood glucose test strips each year, if needed. We will pay the full Fund Rate for blood glucose test strips that are on our medicine list (formulary). Blood glucose test strips that are not on our list will be funded up to the monthly Chronic Drug Amount that applies on your specific plan.

- **Rewards for reaching personalised health targets:** You could qualify to get rewarded for achieving your personalised health targets – to do this, download the Discovery app and start *Track Your Health* for details.

# ABOUT SOME OF THE TERMS WE USE

There may be some terms we use that you are not familiar with. Here are the meanings of these terms

Term	Description
Care navigators	A dedicated team who will proactively help you to: <ul style="list-style-type: none"><li>■ Understand your diabetes-specific benefits</li><li>■ Register on our digital tools</li><li>■ Choose and engage with health professionals on the full-care team (podiatrist, dietitian and so on)</li><li>■ Get the most out of the programme by using the benefits available.</li></ul>
Chronic Illness Benefit	The Chronic Illness Benefit covers you for a defined list of chronic conditions, like diabetes.
Designated service provider (DSP)	General practitioners (GPs) and specialists who: <ul style="list-style-type: none"><li>■ Are part of the Discovery Care Coordination Network or the Premier Plus GP Network</li><li>■ Have contracted with us to provide you with coordinated care for defined chronic conditions.</li></ul>
Diabetes Cardiometabolic Care Programme	The care programme that opens up benefits to help you throughout your journey. This programme is offered by the Fund and administered by Discovery Care Coordination.
Diabetes Cardiometabolic Care Programme basket of care	<b>Your benefits include:</b> <ul style="list-style-type: none"><li>■ Doctor consultations for diabetes and other chronic conditions</li><li>■ 1 foot (podiatry) screening per year</li><li>■ 1 eye screening per year</li><li>■ 1 biokineticist consultation per year</li><li>■ 2 dietitian consultations per year</li><li>■ Diabetes-related blood tests (pathology)</li><li>■ Diabetes coaching and education for high-risk members</li></ul> The Fund pays for medicine, devices and consumables that are listed on the Fund's Chronic Illness Benefit treatment list (formulary).
Emergency medical condition	An emergency medical condition, or emergency, is the sudden – and, at the time, unexpected – start of a health condition that requires immediate medical and surgical treatment.  If it is not treated, it could result in: <ul style="list-style-type: none"><li>■ A serious impairment to bodily functions</li><li>■ A serious dysfunction of a bodily organ or body part</li><li>■ A high risk of death.</li></ul> An emergency does not necessarily mean you have to go to the hospital.  We may ask you for information to confirm the emergency.
Health coaching	A coaching programme we offer to support you if you are at high risk from diabetes. This is done with your doctor's help.
HealthID	HealthID is an online digital platform that gives your doctor fast, up-to-date access to your health information. Once you have given your doctor consent, they can use HealthID to view your medical history, refer you to other healthcare professionals and check the results of any medical tests you have.
ICD-10 diagnosis code	A clinical code that describes diseases, signs and symptoms, abnormal findings, complaints, social circumstances and external causes of injury or diseases, as classified by the World Health Organization (WHO).
Premier Plus GP	A Premier Plus GP is a network GP who has contracted with the Fund to provide you with coordinated care for defined chronic conditions.
Prescribed Minimum Benefits (PMBs)	Under the Medical Schemes Act (No 131 of 1998) and its Regulations, all medical schemes must cover costs for the diagnosis, treatment and care of: <ul style="list-style-type: none"><li>■ An emergency medical condition</li><li>■ A defined list of 271 diagnoses</li><li>■ A defined list of 27 chronic conditions.</li></ul> These are called Prescribed Minimum Benefits.  The Council for Medical Schemes has set the following rules for accessing Prescribed Minimum Benefits: <ul style="list-style-type: none"><li>■ Your medical condition must qualify for cover and be part of the defined list of Prescribed Minimum Benefit conditions.</li><li>■ The treatment needed must match the treatments in the defined benefits.</li><li>■ You must use the designated service providers (DSPs) in our network. This does not apply in emergencies. However, even in an emergency, you may be transferred to a hospital or other service providers in our network once your condition has stabilised – if this is possible and in line with the rules of the scheme.</li><li>■ If you do not use a designated service provider and it is not a medical emergency, we only pay up to 80% of the Scheme Rate. You have to pay the rest.</li></ul>
Fund Rate	If your treatment doesn't meet the above criteria, we will pay according to your plan benefits.  This is a rate that is paid by the Fund for healthcare services from hospitals, pharmacies, healthcare professionals and other providers of health services.
